The Southern Humboldt Community Park property requires a change of landuse designation to Public Recreation on 400-acres and a rezoning from Agriculture Exclusive to Public Facility on approximately 90-acres.

This rezoning is necessary to fulfill the community's intended uses for this property. It will provide us with trails, a playground, a place for gathering, events, and much needed sports facilities.

The Southern Humboldt community is proud that we have created a park that can support itself independently. We request that you allow our community to use this property for public benefit.
